A RESOLUTION

No. 31-20(n)

HEREBY AMENDS RESOLUTION NO. 31-20(M) TO RESCIND THE EMERGENCY CURFEW MANDATE AND STAY AT HOME ORDER

WHEREAS, the Chippewa Cree Tribal Business Committee is the governing body of the Chippewa Cree Tribe of the Rocky Boy's Indian Reservation by the authority of the Constitution and By-Laws of the Chippewa Cree Tribe approved on the 23rd day of November, 1935, and;

WHEREAS, pursuant to their inherent sovereignty and Constitution and By-Laws of the Chippewa Cree Tribe, the Chippewa Cree Tribal Business Committee is charged with the duty to promote and protect the health, security and welfare of the Tribe, and;

WHEREAS, on the 16th day of March 2020 by Resolution No. 24-20, the Chippewa Cree Tribal Business Committee declared a State of Emergency to exist within the exterior boundaries of the Rocky Boy's Indian Reservation due to the communicable disease Coronavirus Disease 2019 (COVID-19), and;

WHEREAS, on the 15th day of January 2021, by Resolution No. 31-20(m), the Chippewa Cree Tribal Business Committee update the **EMERGENCY CURFEW MANDATE** and **STAY AT HOME ORDER** for all individuals within the exterior boundaries of the Rocky Boy's Indian Reservation, and;

WHEREAS, the Chippewa Cree Tribal Business Committee deem it necessary and in the best interest of the Tribe to rescind the **EMERGENCY CURFEW MANDATE** and **STAY AT HOME ORDER** restriction imposed by Resolution No. 31-20(m), and;

WHEREAS, the Chippewa Cree Tribal Business Committee deem it necessary and in the best interest of the Tribe to rescind Title IV, Chapter 5, to include Section 5.8, **EMERGENCY CURFEW MANDATE**, and;

WHEREAS, the Chippewa Cree Tribal Business Committee deem it necessary and in the best interest of the Tribe to reinstate Section 4-5-112 which provides that

4-5-112. Curfew violation.

(1) Every person under the age of 18 years is subject to curfew times as follows:

(a) 11:00 p.m. until 6:00 a.m. the following morning.

(2) Parents or guardians of children under the age of 18 are responsible for curfew compliance.

Exceptions are permitted if the child is under the immediate supervision of a parent, guardian, or other adult approved by the parent or guardian. A child may attend authorized school functions without such supervision. A child may attend religious activities without such supervision.


WHEREAS, the Chippewa Cree Tribal Business Committee affirms that all resolutions, or parts of the same, that are inconsistent with the provisions of this Resolution, are hereby repealed to the extent of such inconsistency, now;

THEREFORE, BE IT RESOLVED that the Chippewa Cree Tribal Business Committee hereby amends Resolution No. 31-20(m) to rescind the **EMERGENCY CURFEW MANDATE** and **STAY AT HOME ORDER** restriction for all individuals within the exterior boundaries of the Rocky Boy's Indian Reservation, unless provided otherwise within this Resolution.


FURTHER, BE IT RESOLVED that this Resolution shall be effective on March 11, 2021, and shall remain indefinitely until rescinded by the Chippewa Cree Tribal Business Committee.
