## Introduction

The Chippewa Cree Tribal Court convened a strategic planning process to update goals, objectives and activities. An important objective will be to improve access to and understanding of the Tribal Court System through a multi-faceted approach. Therefore, the Tribal Court will disseminate a news letter to the community to provide information about new and existing programs, criminal court dispositions and notify individuals when they cannot be found in the community to serve as notice to appear for court.

## Stand on a Strong Cultural Foundation

The CCTC is devoted to the support of tribal community members' justice system through education, information, sharing and advocacy. The Chippewa Cree Tribal Court will strive to provide traditional means of resolving disputes in all facets of the justice system. In a concerted effort to strengthen the court's ability to evolve its shift toward culturally relevant and appropriate justice, the CCTC developed a Mission statement to reflect the enhancement of the tribal justice system.

## **MISSION: THE CHIPPEWA CREE TRIBAL COURT, GUIDED BY CULTURE AND TRADITION, WILL PROVIDE EQUAL JUSTICE FOR ALL.**

The Chippewa Cree Tribal Court recognizes that to be successful in the accomplishment of the mission an integral value and belief system is needed. The CCTC strategic planning sessions spurred discussion and the result is the development of Guiding Principles.

- ◇ The CCTC is a branch of government and operates in the spirit of self-governance, pursuant to the Tribal Constitution and By-Laws;
- ◇ The CCTC ensures equality, fairness and respect for everyone who utilizes the system;
- ◇ The CCTC will recognize and respect culture and traditions within our community;
- ◇ The CCTC shall adhere to strict ethical standards; and
- ◇ The CCTC exercises cooperation with other jurisdictions.

The foundation of organizational culture lies with the values and beliefs that reflect the way in which the organization conducts carrying out its mission. The CCTC defined principles to define and reinforce the values and beliefs of the organization for the long-term success of the Tribal Court.

## Healing to Wellness Enhancement Program

Healing to Wellness Enhancement Programs are available. The Chippewa Cree Tribal Courts will enhance services of the Adult Healing to Wellness Court to respond to and prevent alcohol and substance abuse related crimes on the Rocky Boy's Indian Reservation through the provision of culturally relevant and appropriate evidence based co-occurring treatment services.

The Healing to Wellness Team monitors the participants' progress. Members consist of the Judge, Prosecutor, Program Coordinator, Enforcement Officer, Law Enforcement, Stone Child College, TANF, Social Service, WSHC, Behavioral Health and other Court staff. These individuals work together as a team to assist the participant in completing his or her treatment plan requirements.

There are Four Phases of the Program

1. Introduction/Information – Learning About: why you are in the program; the mental, emotional, physical, and spiritual effect of using alcohol and/or other drugs; what to expect from the program and what will be expected from you.
2. Personal Responsibility – Accepting that: you have a problem with alcohol and/or other drugs; this problem has hurt you, your family, and your community; you can make changes for the better which will improve your life and the lives of those around you.
3. Cooperation/Accountability – Be willing to: Cooperate and follow the treatment program, encourage others to do the same/be a role model; make better choices; live a good life, free of alcohol and other drugs; develop a plan to resist relapse.
4. Completion/Continuing Growth and Wellness – Succeeding in: working through the other phases; leading a constructive life without alcohol and other drugs; learning new things about yourself; having a plan to continue your wellness; making a difference for yourself, your family, and your community.

**24/7 Probation Program:** Clients are ordered to participate in this program and/or voluntarily agreed to this program as a condition of bond or pre-trial release, as a condition of suspended sentence or probation. The following requirements will apply to all participants in this program. Participants are required to accomplish two (2) preliminary breath tests (0.00%) daily, once in the morning and once in the evening.

**Chippewa Cree Tribe Children's Court Juvenile Justice** Lonna Johnson, Children's Court Counselor/Family Advocate 395-4735 ext 227. The Chippewa Cree Tribal Court proposes to address our most pressing needs by the enhancing the Chippewa Cree Tribe Children's Court through implementing an Informal Process and providing services to clients in the formal court. The following strategies and programs will be implemented with all formal and informal court probation clients: MRT, Interactive Journaling and partnering with TANF to refer clients' legal guardians to Parent Training. Lonna also serves as the half-time Project Coordinator for the Suicide/ACE/IPV Project. The overall goal of the project is to reduce the number of Suicide/ Adverse Childhood Experience (ACE) and Intimate Partner Violence rates and increase referrals to the health system that strengthen Tribal public health capacity in response to the aftermath of COVID-19 to prevent injuries/violence focusing on awareness and prevention of Suicide, Adverse Childhood Experiences (ACEs) Intimate Partner Violence (IPV) and expand assessments and treatment services on the Rocky Boy's Reservation.

**Public Defender -** Charles Walking Child 395-4735 ext 229. The mission of the Tribal Public Defenders Office is to provide a requisite balance of quality legal representation to Indian criminal defendants in the prosecution of criminal cases within the courts of the Chippewa Cree Tribal Justice system by seeking dispositions that are effective in addressing the underlying problems that contribute to criminal behavior, thereby reducing recidivism and enhancing public safety without compromising our judicial responsibilities to those represented. The Goals of the Public Defenders Office are:

- ◆ To improve the quality of legal representation for those unable to afford legal counsel and who face the loss of their liberty, and thereby to enhance the administration of justice;
- ◆ To safeguard the rights of indigent individuals, thereby protecting the rights of all members of the Chippewa Cree Tribe;
- ◆ To insure that representation is offered to those eligible to receive representation.

The public defender shall represent individuals who qualify for the Public Defenders Program, represent defendants accused of crimes in the Chippewa Cree Tribal Court, with written consent of the defendant. Representation shall be provided, by the Court assigned Public Defender, at all stages of the proceeding following the filing of a complaint and Notice of Representation. The tribal public defender shall take all necessary steps to investigate the facts of each case to make sure each case is fairly presented from the side of the defense. Public Defender must provide their clients with the highest quality representation. They are expected to be timely in filing all submission to the court. Using the correct heading and elements required in each filing. To maintain accurate records of all client contacts and court proceedings. All staff will handle all case materials and files in a manner consistent with the confidential nature of the materials in their care.

## Citizen Complaint Process

The Chippewa Cree Tribal Court (CCTC) staff will strive to always treat customers with courtesy and respect regardless of whether they are a petitioner or a respondent. The CCTC will strive to work expeditiously on all court cases to ensure that justice is served for customers who fall under their jurisdiction.

Excellence in customer services means that educated and knowledgeable staff must be ready to assist tribal citizens, visitors, clients, customers, or program participants in receiving the help or assistance they need. Excellence in customer services also means, that as an employee, you will offer services in a fair manner that treats everyone with courtesy and respect. We will make diligent efforts to assist customers who have questions and concerns at the time of their request whether the request is via phone or in person. If we are unable to give an immediate and/or satisfactory answer at the time, staff will make every effort to research the situation and find the requested information. We will contact and relay the information to them within 5 business days.

However, although the CCTC staff will strive to remain professional and treat customers with courtesy and respect, it is also their right to be treated with respect. The Chippewa Cree Tribe has established an ordinance making it a tribal offense for any person who engages in threats, harassment, intimidation, or harm to the person or property of any employee performing his or her duties in service to the Chippewa Cree Tribe of the Rocky Boy's Indian Reservation. If CCTC staff is in a situation where a person is cursing or yelling at employees, or in other ways threatening, it is the right of employees to ask them to stop. If it is on the phone, ask them to stop with a warning that you will hang up. If they continue, gently hang up on the phone. If it is a person-to-person situation, staff will respectfully ask them to stop. If they refuse, staff will inform them they can either leave or they will call the security officer or the police.

### **Administrative Customer Complaint Process**

The Tribal Court has implemented an Administrative Citizen Customer Complaint Process so that any complaint against staff members, Judges or members of the Judicial Commission will be handled uniformly and expeditiously.

The 1st step in the process is identifying what process will be followed by answering the following questions:

1. Is the customer's complaint case related? If the answer is yes, then the next question is:
2. Is the customer dissatisfied with the outcome of the case? If the answer is yes, then the customer is oriented to the Court of Appeals process.
3. If the complaint is not related to a court case then the administrative citizen customer complaint process will begin by asking the complainant to complete a Citizen Complaint Form.

If the customer's complaint is related to an employee's conduct or job performance, the employee's immediate supervisor will begin investigating the incident and present the findings to the Court Administrator.

If the customer's complaint is related to a Judge's conduct or job performance, the Chief Judge will begin investigating the incident and present the findings to the Judicial Commission and/or Court Administrator. If the customer's complaint is related to the Chief Judge or Court Administrator's conduct then the Chair of the Judicial Commission will investigate the incident and present the findings to the Judicial Commission. If necessary, Human Resource and Compliance Officer will assist with the investigation.

Tribal Court staff should always take the initiative in resolving customer's complaints. However, in circumstances when resolution by the staff member is not forthcoming or appropriate, the complaint process will flow to the appropriate fact finder.

## Administrative Customer Complaint Process

The Tribal Court has implemented an Administrative Citizen Customer Complaint Process so that any complaint against staff members, Judges or members of the Judicial Commission will be handled uniformly and expeditiously.

The 1<sup>st</sup> step in the process is identifying what process will be followed by answering the following questions:

Is the customer's complaint case related? If the answer is yes, then the next question is:

Is the customer dissatisfied with the outcome of the case? If the answer is yes, then the customer is orientated to the Court of Appeals process.

If the complaint is not related to a court case then the administrative citizen customer complaint process will begin by asking the complainant to complete a Citizen Complaint Form.

If the customer's complaint is related to an employee's conduct or job performance, the employee's immediate supervisor will begin investigating the incident and present the findings to the Court Administrator.

If the customer's complaint is related to a Judge's conduct or job performance, the Chief Judge will begin investigating the incident and present the findings to the Judicial Commission and/or Court Administrator.

If the customer's complaint is related the Chief Judge or Court Administrator's conduct then the Chair of the Judicial Commission will investigate the incident and present the findings to the Judicial Commission. If necessary, Human Resource and Compliance Officer will assist with the investigation.

Tribal Court staff should always take the initiative in resolving customer's complaints. However, in circumstances when resolution by the staff member is not forthcoming or appropriate, the complaint process will flow to the appropriate fact finder.

The designated fact finders will be as follows:

*Court Administrator:* When the complaint cannot be resolved by a staff member, or involves a staff member, and the matter is not directly related to the job performance of the Court Administrator, they will act as the fact finder.

*Chief Judge:* When the complaint involves an Associate Judge and the matter is not directly related to the job performance of the Chief Judge, they will act as the fact finder.

*Judicial Commission:* When the complaint cannot be resolved by the Court Administrator or the Chief Judge or if the complaint directly involves either of these staff, the Appellate Court, or a member of the Judicial Commission; the Human Resource and/or Compliance Officer will act as the fact finder. The Primary Fact Finder will report findings to the Judicial Commission Chairperson. Any action taken regarding these findings must be approved and acted upon by the Judicial Commission. If the action is against a specific Judicial Commission member, the Attorney General and Business Committee will be informed of the findings.

This complaint procedure will be posted in clear view in the lobby of the Chippewa Cree Tribal Courthouse. Citizen Complaint forms will be made available to the customer upon request. Complaint forms must be completed by the customer and must be accompanied by a detailed description of the situation for which the complaint is being made. The Citizen will be provided information on how to access the Code of Judicial Conduct. Submitted complaint forms will be date-stamped by the secretary upon receipt and routed to the appropriate fact finder with a copy routed to the immediate supervisor or court administrator. Within 30 days of receipt of a completed complaint form, including a detailed description, the fact finder will review the circumstances of the case and the complaint to make a written determination. The written results will be mailed to the complainant within 10 days of the determination. If a complaint has been validated, corrective action will be taken to resolve the situation expeditiously in accordance with the Chippewa Cree Tribe's Personnel Policies and Procedures.

All complaints will be stored by the Court Administrator in the appropriate employee's files. Cumulative complaints will be reviewed annually to identify chronic or systematic problems. If and when such problems are identified, the CCTC immediate supervisor will implement measures of corrective action in an effort to enhance customer service. If the complaint is not validated the complaint will be removed from the employee's personnel file.
